

**Kensington School District Hearing  
Minutes January 10, 2018**

Mrs. Favara called the public hearing to order at 6:05 PM

Mrs. Favara reviewed the 2018-19 proposed operating budget highlighting the major increases in the FY2019 budget. The total of major increases in \$256,713.00. She then reviewed the major decreases in the proposed operating budget, which is a total of \$22,280.00. (see attachments 1 and 2)

Community members asked questions regarding anticipated class size, snow plowing expenses, and special education expenses. Also a question was raised regarding any findings on the audit. Mrs. Asbell shared the results of the audit are not available yet, however when the findings come in the KES Board will review the report. It will be listed on the agenda when the review is available.

Mr. Cole reviewed warrant article number two; the collective bargaining agreement. The process was described and then Mr. Cole highlighted major changes that were negotiated, one of them being a change in health care plan which if passed would be a savings of about \$28,000.00 next year. The salary increase for year one is \$48,819.00.

Mr. Cole explained another major change was this contract is for four years instead of only two. Mr. Cole asked for questions from the public. Questions on health care were asked and discussed. Mr. Cole explained these changes are also due to a change in insurance provider which the teachers requested.

Mr. Cole made a motion to close the Budget Hearing. Mrs. Ramsey seconded. All in favor. The Public Budget Hearing was closed at 6:25 pm.

Should this article be defeated, the default budget shall be \$2,693,794, which is the same as last year, with certain adjustments required by previous action of the District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. The Kensington School Board recommends \$2,879,652 as set forth on said budget.)
